I was told I got some F

A) I remember them extracting me from the car DAVIS was more aggressive pulling my arm out in a way that could have bent or broken it but as I managed to show visual concern with my eyes and I was making sufficient progress that the extraction went smoothly. At no time did they say I was under arrest.

They put me into the squad car and I told them I'm entering the car under threat duress and coercion.

standing GARY asked some questions about the stop. Why didn't I stop right away? I mentioned that I was calling a friend who knows a lot about law. The officers took offense and said don't you think we know about law to which I said I'm sure there is lots you know about law.

In Car Background check came back. First Wisconsin, then California. I mentioned that Wisconsin incident I learned how officers lie to gain convictions, that I counted in excess of 20 lies by the time the story hit the newspaper. Later I mentioned off the street is a different kind of Jurisdiction I'd  
heard. Also I pointed out that the freeway is not a safe place  
for Pedestrians, I parked where I felt comfortable, in the shade was more  
convenient for them to search the car, Additionally there is the Security camera  
of the Gas Station.

June 5th woke up at 4am I imagine I went to sleep around 8 pm last night. It was hard to obtain telephone access last night as there were so many people being processed at the intake Desk across from my cell known as "Holding Area #1"

There was alot of clatter noise with people in white inmate uniforms being chained for transport to court I'd guess. one officer was holding handcuffs making clicking noise slowly ~~with~~ by rotating the cuff through its receiver about one click per second id guess.

I arose from my slumber & started a little exercise then realized I should do my morning Rosecrution thing and do the drinking of water. The water tased differently this morning. More fluoride perhaps? I drank less than normal. I exercised & stretched, situps, etc... washed armpits twice at Sink, leg too (left). I asked for (separately) and recieved RAZOR then Shampoo. I'm thinking about court. Will I have time to call Alan one more time to tell him that the Felony charge of EVASION was dropped to a class B misdemeanor says the Sgt.

I need to get this down on paper. the Sgt H \_\_\_\_\_ told me yesterday that they were trying to bring the charge down and that I could be facing 25 years. When I told this later in a phone call Alan & Courtney laughed heartily telling me he was only joking with you.

Breakfast was served about 6:10 am by an inmate in orange escorted by a woman in police uniform - older lady with dyed dark hair.

I witnessed a man in his 20s have his urine tested an officer was confronting him with the failing result of the presence of some kind of drug. I interjected asking the man if he had lost any weight recently because toxing get released from the burking of fat. He said he didn't know. I complimented the officer on his Cool Reading classes - he didn't respond to the comment, I said to be quiet.

I ate peachos and oatmeal - "my favorite!" Leaving the toast and milk to avoid Alegm, wheat BRAIN & Belly Syndrome.

(5) Cronology

I remember being stopped driving slowly 62mph on the freeway. I saw a gasoline station the officer was trying to corral me onto the street but I squeezed my way onto the parking lot there weren't any empty gas stalls to pull into.

on June 4th I asked the guy at the inmate intake desk probably Tim Joseph when my arraignment would be, I was told that I was part of Division 5 which was scheduled for June 12th at the same time I asked if I could speak to the public defender's office or <sup>or DA</sup> and was told they weren't on duty on a Sunday. I needed copies, phone time before morning's hearing. He told SGT <sup>TOTAL PARCHETTA</sup> DRASTED A Request on TP
